

## OFF-LICENCE

### Sections 17 to 20 and 64, Sale and Supply of Alcohol Act 2012

Licence No: 058/OFF/00018/2025

Pursuant to the Sale and Supply of Alcohol Act 2012(The Act), **SL Kalapoi Limited** (the licensee) is authorised to sell alcohol on the premises situated at **57 Williams Street Kalapoi** and known as **Super Liquor Kalapoi**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

#### Conditions

This licence is subject to the following conditions:

(a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day.

(b) Alcohol may be sold only on the following days and during the following hours:

#### From the bottle store only:

**Monday to Sunday 9.00am to 10.00pm**


- (c) The Bottle Store is designated as a supervised area.
- (d) Water must be freely available to customers on the premises during tastings.
- (e) Alcohol must only be sold and displayed within the area marked on the plan submitted with the application.
- (f) The premises are more precisely identified as outlined in a plan date stamped as received by the Waimakariri District Licensing Committee on 24 September 2025.
- (g) A copy of this licence must be displayed at the principal entrance to the premises. The entrance from the Williams Street is designated as the principal entrance.
- (h) The licensee must implement and maintain the steps proposed in their Host Responsibility Policy aimed at promoting the reasonable sale and supply of alcohol.
- (i) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.

#### DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period for which it is renewed.
